FORMAT FOR SUBMISSION OF MEMORANDUM TO 2nd MIZORAM FINANCE COMMISSION IN RESPECT OF DEPUTY COMMISSIONERS ON DISASTER MANAGEMENT

Paragraph 4(vi) of the Terms of Reference of the 2nd Mizoram Finance Commission prescribed that “*In making its recommendations, the Commission shall have regard, among other considerations, to the need to enhance disaster management at the local levels so as to avoid minor disasters such as landslips, etc. at the local levels*”. Kindly provide note on the following points with special reference to the provisions in the Terms of Reference mentioned above with a view to facilitate the Commission make an effective recommendation to enable the local bodies discharge their functions pertaining to disaster management efficiently.

1. Whether or not the Village Level Disaster Management Committees/Local Level Disaster Management Committees/Village Councils/Local Councils in the District prepare “disaster management plan” as provided in Section 32 of the Disaster Management Act, 2005? If Yes, when was the plans last updated?
2. Kindly elaborate the role envisaged for the Village Level Disaster Management Committees/Local Level Disaster Management Committees/Village Councils/Local Councils in the District Disaster Management Plan prepared as per section 31 of the Disaster Management Act, 2005.
3. Kindly elaborate the steps undertaken by the District Administration/District Disaster Management Authority towards “capacity building” of Village Level Disaster Management Committees/Local Level Disaster Management Committees/Village Councils/Local Councils.
4. Suggest measures, if any, for making Village Councils/Village Level Disaster Management Committees/Local Councils/Local Level Disaster Management Committees as the nodal agency for relief and rehabilitation at the village/local level. The 15th Finance Commission has, in fact, stated that making panchayats the nodal agency for relief and rehabilitation will result in improved planning, coordination and monitoring (Para 8.105 of XVFC Report)
5. Kindly provide financial statements towards the utilization of State Disaster Response Fund (SDRF) by the District Disaster Management Authorities/District Administrations as per the format prescribed in the **Schedules** appended.
