Sir,

With reference to the subject mentioned above, I am directed to state that the 2nd Mizoram Finance Commission, a Constitutional body established under article 243-I read with article 243Y, is mandated to discharge the formidable task of recommending the devolution of taxes, duties, tolls and fees levied by the State to rural local bodies, urban local bodies and Autonomous District Councils.

In this regard, the approach of the Commission is to have wide ranging consultations with the stakeholders especially the elected representatives of rural local bodies on issues pertaining to finances of the local bodies.

- 1. To issue meeting notice for the consultative meeting on 29th June, 2022 (11.30AM) inviting (a) Office Bearers of Saitual District Village Council Association, (b) one representative each of all Village Councils within Saitual Town, (c) Project Director, DRDA, Saitual (d) District Local Administration Officer in charge of Saitual District, (e) District Urban Development Officer, Saitual. The meeting may preferably be held in DC Conference Hall.
- 2. To kindly arrange Projector with screen for making powerpoint presentations in the course of the consultative meeting.
- 3. To kindly arrange refreshments for the participants of the consultative meeting. Expenses incurred will be re-imbursed by the Commission.
- 4. To kindly select two or three works implemented under grants from 1st Mizoram Finance Commission, in consultation with District Local Administration Officer, for inspection, preferably after conclusion of the consultative meeting.
- 5. To kindly arrange morning meal for the 29th June, 2022 preferably at Tourist Lodge, Saitual including accommodation for the visiting team, consisting of (a) Chairman, (b) Member Secretary (c) Deputy Secretary, (d) two clerical staff (e) three drivers and (f) one Group 'D' staff.
